The government should prioritize investments in education, healthcare, infrastructure, and job creation to address socio-economic disparities and empower marginalized populations. By addressing root causes of poverty and inequality, Nigeria can create opportunities for social mobility, reduce grievances, and foster resilience against radicalization and violent extremism.
- d. **Enhancing Regional Cooperation.** Given the transnational nature of security threats in West Africa, Nigeria should prioritize regional cooperation and coordination mechanisms to address cross-border crimes, terrorism, and insurgency. This includes strengthening partnerships with neighbouring countries, regional organizations, and international stakeholders to enhance information sharing, border security, and joint security operations. By fostering regional cooperation, Nigeria can effectively combat transnational security threats and promote stability in the wider West African region.
- e. **Promoting Human Rights and Civil Liberties.** Upholding human rights, civil liberties, and the rule of law is essential for building a resilient and inclusive security architecture in Nigeria. The government should respect constitutional safeguards, protect freedom of expression and assembly, and ensure accountability for human rights abuses committed by security forces. By promoting respect for human rights and civil liberties, Nigeria can enhance state legitimacy, build public trust, and reduce tensions between security forces and civilian populations.
- f. **Investing in Community Policing and Conflict Prevention.** Nigeria should prioritize community policing initiatives and conflict prevention strategies to build trust between security forces and local communities. This includes training security personnel in community engagement, conflict resolution, and human rights protection, as well as promoting community-based early warning systems and mediation mechanisms. By empowering communities to participate in their own security governance, Nigeria can

enhance local resilience, prevent conflicts, and build sustainable peace from the ground up. 2. In implementing these recommendations, Nigeria can strengthen its capacity to address internal and external security challenges, promote inclusive governance, and build resilient communities capable of withstanding threats to peace and stability. By adopting a holistic and multi-dimensional approach to security governance, Nigeria can foster sustainable peace, promote human security, and realize its full potential as a prosperous and resilient nation.
