

THE MIDDLE-EAST AND IRAN-ISRAELI MILITARY CONTESTATION BY INSTRUMENTALIZING COERCIVE STATECRAFT

Abstract

The 2023 Gaza War was one of the largest escalations of the Israeli-Palestinian conflict-a longstanding conflict in which Israel and Iran have played important, albeit very different, roles. This paper presents a comparative study of the military statecraft of Israel and Iran squarely focused on strategic objectives, military doctrines, and tactical operations during the war in question. Israel, a country noted for its conventional military superiority, had no choice but to depend much on the available technologies of air superiority, precision-guided munitions, and its Iron Dome missile defense system in keeping deterrence against Hamas and neutralizing its military infrastructure. The larger security doctrine, preferring quick and decisive actions in order to limit casualties and keep stability in the region, is reflected in Israel's "deterrence by punishment" and the use of targeted airstrikes aimed at Hamas capability degradation. In contrast, despite not being a direct participant in the confrontation, Iran played a critical supporting role as the principal patron of Hamas and various Palestinian groups. Through the IRGC, Iran provided critical logistical, financial, and military support to Hamas, engaging a proxy and militia-based form of asymmetric warfare (Katz, 2019). More broadly, Iran's regional strategy is based on undermining Israeli hegemony and building a network of resistance movements all over the Middle East. This paper highlights the ways in which Iran is able to indirectly involve itself in these conflicts through proxy warfare, thereby challenging Israeli military dominance with minimal direct retaliation against itself. A mixed-methods approach is adopted, where qualitative analysis of military reports, speeches, and secondary literature is combined with comparative case study analysis of Israel and Iran's respective strategies (Mearsheimer, 2001). Theoretical frameworks of realism and asymmetric warfare are used to contextualize military decisions made by both nations. While Israel's doctrine is grounded in deterrence and defense, Iran uses regional influence and proxy groups in a heist against the superior technological advantage of Israel. The findings indicate that Israel has technological and military capabilities that afford it an unmistakable tactical advantage, but Iran's indirect approaches through proxies and cyber operations present huge challenges to the objectives set by Israeli interests. This asymmetry is amplified with information warfare and media narratives that have portrayed the conflict to the broader public and intervened with international diplomatic responses. The paper further discusses how the military strategies of both Israel and Iran have wider implications for regional stability, the humanitarian situation in Gaza, and the international response chiefly by the United States and the United Nations. In conclusion, the 2023 Gaza conflict is starkly illustrative of how traditional military power in modern warfare has become complemented and supplemented with cyber capabilities, media manipulation, and proxy engagements. The paper calls on Israel to play a more open-minded diplomatic role to engage or reduce the threat posed by Iranian proxies and calls on Iran to reconsider asymmetric warfare, considering the long-term instability it generates. While it is urging the international community to be more actively involved in peacebuilding and humanitarian efforts, it should turn the conflict without letting it get converted into further escalation.

Introduction

The 2023 Gaza War was yet another round of the chronic Israeli-Palestinian conflict. This is also a very important occasion in the analysis of Israeli military statecraft: advanced technologies, strategic deterrence, and the measured use of forces in the maintenance of security and regional stability. The continuous historical experience in existential threat has evolved the military statecraft in Israel to establish a kind of defensive strategy that will take away threats even before their coming into being, making sure that its military supremacy is not only maintained but also progressed (Shapir, 2021). This doctrine is well reflected in how Israel waged the war in Gaza, using a multi-dimensional military approach in precision strikes, intelligence operations, air superiority, and missile defense systems. The IDF, via state-of-the-art technologies including the Iron Dome, illustrate the interest of the country in protecting its security while minimizing civilian casualties on both sides, both within the country and in Gaza (Herzog, 2017). The deterrence aspect, which has been part of the Israeli military doctrine since its inception, constitutes the nucleus of the state's military statecraft. In other words, its security philosophy is based on the fact that military power, especially the capability of delivering swift and decisive strikes, acts as a deterrent against any opponent, here being Hamas, Hezbollah, and various other militant groups (Shapir, 2021). Deterrence for Israel is not only an issue of being able to inflict damage but also being able to convey that it will act preemptively if threatened. That is what was supposed to be in practice during the Gaza War, as the Israeli airstrikes against Hamas's infrastructure were not just tactical but symbolic of its greater message of deterrence (Kilcullen, 2016).

It is through these operations that Israel wanted to send a signal of its preparedness and capability of hitting the epicenter of Hamas's military assets as a way of deterring future hostilities Herzog, 2017, Israeli military doctrine underlines the role of the technological edge in its defense strategy. Israel possesses very sophisticated military technology, ranging from the improvement of its interception capabilities through the Iron Dome missile defense system against rocket barrages fired from Gaza, to very advanced drones and precision-guided munitions. The Iron Dome, for example, was the backbone of protection for Israeli civilians against the Hamas rocket barrages, which substantially reduced the risks of casualties and physical damage in Israeli cities (Shapir, 2021).

More than this, the pin-point strikes from Israel, through drones and fighter jets, demarcate the technological edge and reflect the statecraft of its military in connecting highly advanced war tools to strategic objectives with minimum collateral damage. Another cornerstone of Israel's military strategy is the centrality of intelligence and cyber operations, which match or complement its kinetic military capabilities. The intelligence apparatus of the state of Israel, including the Israeli Intelligence Corps and the Mossad, is a core part of the country's security framework, providing real-time intelligence that informs military decisions in times of conflict (Kfir, 2020).

Intelligence thus enabled the precise targeting of top-ranking Hamas leaders to then target key military infrastructures that impeded any adversary from mounting reasonably effective resistance. This superiority in intelligence, combined with the technical excellence of the country, creates strategic level effects, allowing the nation of Israel to strike deep with surgical and enhances its effectiveness in military statecraft. This is also the case with Israel's military statecraft, preconditioned as it is by the geopolitical facts of its existence. A small country with hostile neighbors, Israel's defense is preconditioned on regional dominance and the thwarting of any existential dangers. Although the conflict in Gaza is presented as a local issue, it forms part of Israel's greater

strategy of ensuring regional security. The conflict with Hamas A looks at the Gaza Strip and other Palestinian factions, in many ways, is a microcosm of the current struggle of Israel with its security in the Middle East. This larger canvas puts into perspective the crucial role that military statecraft plays in the survival of Israel in one of the world's most volatile regions.

Weighed by a mixture of technological innovation, intelligence superiority, and strategic deterrence, Israeli military dominance acts as a cornerstone of its foreign policy and its approach toward conflict resolution (Mearsheimer, 2001). The statecraft of Israel in the realm of the military has a great deal intrinsically to do with the role of public diplomacy and media narratives in shaping both domestic and international perceptions. During the 2023 Gaza War, Israel massively employed PR to justify military operations, emphasizing the need for self-defense and the proportionality of the same in light of Hamas rocket fire (Luttwak, 2001). The state's ability to frame its military actions within the context of legitimate self-defense has been important in garnering domestic support and international understanding (Nye, 2004). The use of information warfare and media strategy shows how Israel folds non-kinetic elements of its power into military statecraft—reinforcing the message of protection of citizens and national security. Therefore, the reduction of Israel's statecraft does not have the mere application of force; it is a complex diversified strategy that encompasses technological superiority, intelligence gathering, psychological operations, and strategic deterrence. The method should achieve not only military but also political gains to an extent that will minimize threats against Israel. One such arena where the Israeli military statecraft was tested was the Gaza conflict, but it indeed provides a peephole into how the country's military capabilities and doctrines work within a broader security framework.

The following sections discuss the intricacies of the statecraft of Israel's military during the 2023 Gaza War, with regard to the strategic, tactical, and technological dimensions of the military operations of the country. From this it will be discussed how this overwhelmingly military advantage, coupled with its all-important political objectives, shapes the trajectory of the Israeli-Palestinian conflict and consequently impacts the broader dynamics in the Middle East.

Material and Methods

The research methods used to analyze Israel's military statecraft during the Gaza War include qualitative content analysis, comparative case studies, and theoretical frameworks culled from international relations and military strategy.

Qualitative Content Analysis

A primary method employed was content analysis of military reports, speeches, and media coverage. This allowed for the extraction of key themes related to Israel's military strategies, including deterrence, technological innovation, intelligence gathering, and public diplomacy. Content analysis was particularly useful for examining how Israeli leaders framed the necessity of military action during the Gaza War and how these messages were communicated to both domestic and international audiences (Herzog, 2017). For example, public speeches and official statements revealed how Israel framed its self-defense obligation in response to an obvious existential threat. Regarding the general concept of deterrence, the military action can be generally framed as not just a reprisal but as a preventive measure itself (Shapir, 2021).

Case Study Comparison

Case studies of past conflicts involving Israel, especially the 2008-2009 Gaza War (Operation Cast Lead) and the 2014 Gaza War (Operation Protective Edge), provided insight into Israel's military strategies. Comparing these past cases to the 2023 Gaza War allowed for the identification of patterns in military behavior and strategic choices that could explain the way in which Israel's military statecraft has evolved (Kfir, 2020). This comparison showed how far Israel has moved apart over time on technological and operational abilities for missile defense and precision strikes. Furthermore, the use of case studies from asymmetric warfare literature, such as those examining conflicts between technologically advanced nations and non-state actors (e.g., Israel vs. Hamas), provided useful

insights into Israel's reliance on superior military technology to overcome the challenges posed by asymmetric warfare (Kilcullen, 2016).

Theoretical Frameworks

The realist theory provides that the main reason for states to act in their interest is for the guarantee and security of the states. Realism best explains Israel's preoccupation with deterrence and pre-emptive strikes as strategies of survival against regional hostile neighbors and existential threats (Mearsheimer, 2001). The notion of the "security dilemma" was quite applicable in analyzing the interaction between Israeli actions and Palestinian resistance, whereby Israeli military response to Hamas's activities in Gaza is both defensive and preventive, yet contributes to further cycles of violence. Jervis (1978). Israel's military superiority in conventional warfare is juxtaposed against the tactics used by Hamas and other militant groups in Gaza, which rely on asymmetric tactics like rocket attacks, tunnels, and guerrilla warfare. The theory of asymmetric warfare provides an important framework for understanding how Israel adapts its strategies to counteract these nontraditional threats (Kilcullen, 2016). For instance, Israel's reliance on precision-guided munitions and advanced missile defense systems directly counters the relatively primitive but effective tactics employed by Hamas. This framework allowed for a deeper analysis of the strategic considerations underlying Israel's military response and the technological innovations it deploys to mitigate the impact of these asymmetric tactics.

How Methods Contributed to Elucidating the Position

The chosen methods were crucial in supporting the argument that Israel's military statecraft is highly effective due to its integration of technological innovation, intelligence capabilities, and strategic deterrence. Content analysis of military reports and official statements revealed that Israel's military actions during the Gaza War were framed around its need to maintain deterrence and protect its civilian population. These findings are consistent with existing literature on Israel's strategic doctrine, particularly its reliance on preemptive strikes as a form of strategic messaging (Herzog, 2017).

The case study comparisons highlighted the continuity of Israel's military doctrine across multiple Gaza conflicts, reinforcing the argument that Israel has refined and adapted its military tactics over time, particularly in its use of precision weaponry and intelligence-gathering capabilities (Kfir, 2020). The historical analysis above has demonstrated how, within this context, the military responses of Israel to Gaza have been framed through an evolving technological environment, enabling Israel to maintain military superiority in asymmetric environments. Finally, the use of realist theory and asymmetric warfare provided an intellectual framework for understanding the broader strategic goals behind Israel's military actions. Realism illuminated Israel's pursuit of security and survival as the central driver of its military decision-making, while asymmetric warfare theory highlighted the technological innovations that allow Israel to counteract the more unconventional tactics used by Hamas and other groups in Gaza (Kilcullen, 2016). Together, these methods reinforced the view that Israel's military statecraft is not just about technological prowess, but about leveraging that technology in a way that ensures Israel's long-term security and strategic positioning in the Middle East.

Literature Review

In this respect, Israel's military statecraft is under consideration with great attention to both an academic and policymaking audience regarding the 2023 Gaza War. A review of the existing literature provides startlingly interesting insights on the critical ingredients of the military strategy, doctrines, and technologies, besides providing a theoretical and empirical grounding necessary for understanding how these elements come together to form Israel's overall approach to conflict resolution and deterrence. This literature review has surveyed a variety of academic articles, government reports, books, and media analyses—that have contributed to reinforcing this argument: that Israel's military statecraft is not only technologically advanced but also strategically sound in ensuring security with political stability. The literature reviewed is grouped into themes of deterrence theory, technological superiority, intelligence operations, and Israel's use of public diplomacy and media. All of these

themes form the centerpiece of explaining Israel's military behavior in the Gaza conflict and underlining the general doctrine of its statecraft.

Deterrence and Pre-Emptive Military Strategy

A foundational concept in understanding Israel's military statecraft is the theory of deterrence, which suggests that military power is best used not just reactively but proactively, to prevent adversaries from acting in ways that threaten national security (Shapir, 2021). This principle has been central to Israel's military doctrine since its establishment in 1948. Israel's use of deterrence was strongly supported by several scholars and military experts, who argue that Israel's preemptive strikes—such as those launched during the Gaza War—are a critical tool for ensuring its survival in a volatile region.

For example, Herzog (2017) highlights Israel's policy of "deterrence by punishment," which aims to convince adversaries that any attack on Israel will result in devastating retaliation. This concept is vital in understanding why Israel often strikes first, even in situations where its security is not immediately threatened. The comparison provided by Herzog between Israel's defense policy in the conflicts at Gaza in both 2014 and 2008-2009 links any military action to a greater deterrence narrative, underlining the fact that Israel's military posture is defensive rather than expansionist. This supports the present study's stance, which has considered Israel's military statecraft in Gaza to be one of deterrence, undertaken with a view to maintaining regional stability and neutralizing threats before they become tangible (Al-Maliki, 2022). Shapir (2021) adds further nuance to this by detailing how Israel's military doctrine combines deterrence with preemptive military action. The concept of preemption is crucial for understanding Israel's approach in Gaza, where it often launches airstrikes and missile attacks against Hamas targets in anticipation of future attacks. These preemptive actions are not simply about inflicting damage on Hamas; they are a means of signaling to potential aggressors that Israel will act decisively at the first sign of danger. This strategic use of force as a means of shaping the battlefield and deterring future threats has been integral to Israel's ability to maintain security and prevent escalation in the region (Shapir, 2021).

Technological Superiority and Precision Warfare

One of the most distinctive features of Israel's military statecraft is its reliance on technological superiority, particularly in the realm of precision warfare. Israel has invested heavily in technological innovations that allow it to conduct highly effective military operations with minimal collateral damage. The most obvious example is the Iron Dome missile defense system, which saved the lives of numerous Israeli civilians from the rockets fired from Gaza. Shapir (2021) and Herzog (2017) look at the current state of technological development within Israel and said that it was this very military edge in advanced air-power employment, precision-guided munitions, and missile defense systems that won asymmetric conflicts and guaranteed deterrence. According to Herzog, 2017, Israel's military superiority simply accrues from investment in technology, allowing it to achieve tactical goals with few casualties among its army or even minimal civilian deaths inside Gaza. Perhaps the clearest manifestation of this innovation in Israeli militarism is the Iron Dome, which has successfully intercepted thousands of rockets fired from Gaza since its deployment. This system has saved not only Israeli lives but assured that Israel can strike back militarily without being dragged into prolonged urban warfare—a situation that would lead to massive civilian losses on both sides. The technological advancement contexts presented by Herzog 2017 are essential to the present paper's position because such contexts outline that Israel's military statecraft is deeply intertwined with technological capability, permitting the former to conflict without losing its edge over the opponent.

Kilcullen (2016) extends this by considering asymmetric warfare, a concept at the core of Israel's operational strategy in Gaza. This is where Israeli technological advancements allow it to neutralize any kind of threats posed by things such as Hamas through less technologically evolved yet highly effective tactics—suicide bombings, rocket attacks, and tunnel warfare. According to Kilcullen (2016), the fact that Israel can carry out precision strikes against these irregular, asymmetric, and unconventional targets is a reflection of its military evolution to

negate asymmetric tactics. This supports the line of argument set out in this paper that Israel's superior technology provides it with the capability to dominate asymmetrically waged warfare.

Intelligence Operations and Cyber Warfare

Central to Israel's military statecraft is the intelligence that supports its military operations and underpins strategic decision-making. Kfir (2020) identifies the important role played by Israeli intelligence agencies, particularly the Mossad and Shin Bet, in collecting vital pieces of information regarding Hamas' activities, thus informally dictating Israel's pre-emptive strikes. The success of Israel's military actions during the Gaza War is often credited to its intelligence gathering capabilities, which allow the IDF to strike with surgical precision against Hamas leadership and key infrastructure, thereby limiting the organization's ability to respond effectively. Kfir (2020) added that there are also advanced cyber warfare methods being involved in the state's intelligence operations. Moreover, Israel's cyber capabilities enable the disruption of Hamas' communications, interference with rocket launch systems, and even the sabotage of critical infrastructure. Such intelligence-driven operations become part of Israel's broader military statecraft as such, building from this nation's experiences, enhances the execution of complex, multi-dimensional operations with minimal collateral damage. This aspect of Israel's military strategy fortifies this paper's stance, presenting that Israel's military action in view of Gaza is informed not just by issues of deterrence but by an effective intelligence apparatus, highly sophisticated and able to act quickly (Nye, 2004).

Public Diplomacy and Media Strategy

An often disregarded yet vital aspect of Israel's military statecraft is its public diplomacy and media strategy, which plays a fundamental role in formulating domestic and international impressions about its military campaigns. Nye (2004) coined the term 'soft power,' a form of power expressed through non-coercive behavior in order to gain geopolitical goals. In the case of Israel, this includes efforts to control perceptions regarding the international community through public statements, media campaigns, and other forms of diplomacy. Nye (2004) notes that Israel has been successful in using the media to frame military actions as necessary acts of self-defense and protection for its own citizenry. Analyses of public statements by Israeli officials, as debated by Luttwak (2001), also reveal how Israel contextualizes its military operations within a broader strategy of deterrence and national security. Israel designs these operations as responses to provoke international sentiments of support and reduce criticism, especially from opponents and human rights groups.

This aspect of Israel's military statecraft, as detailed by Nye (2004) and Luttwak (2001), reinforces the view that Israel's military actions are not isolated incidents of violence but part of a larger strategy that includes shaping international opinion to support its right to self-defense. Each of these—the use of deterrence, technological superiority, intelligence operations, and public diplomacy—is set in context by the literature reviewed for this study. These themes deepen the understanding of how Israel approaches conflict, particularly in the Gaza context, underlining strategic calculations behind its military actions. When combined, the knowledge drawn from deterrence theory, technological innovation, intelligence capabilities, and media management allow for a strengthened case that Israeli military statecraft not only secures Israel but also sustains region-wide stability. Analysis of these sources fully corroborates the view that Israel's military statecraft, as revealed in the Gaza War, represents a sophisticated combination of modern military technology, strategic foresight, and political maneuvering that shapes the course of events in the Israeli-Palestinian conflict.

Findings and Discussion

The key issues and topical critical findings from the analysis of Israel's military statecraft in the 2023 Gaza War both reflect deeper dynamics within the Israeli-Palestinian conflict and within the broader geopolitical configuration. The findings would therefore presumably say something regarding Israel's strategic goals, military doctrine, and how technology and intelligence contour the outcome of its military operations. These findings further indicate the complicated interaction between military power, diplomacy, and public perception, while ethical concerns regarding military action and the effects on both Israeli and Palestinian civilians are met. The

section discusses key findings derived from the literature review, identifying topical issues that emerge from the broader implications of Israel's military statecraft.

Key findings

Technological Superiority as a Strategic Edge

Among the real striking findings from the current research is the primacy of technological superiority within Israeli military statecraft. Thus far, Israel's capacity to operationalize state-of-the-art technologies, such as the Iron Dome missile defense system, precision-guided munitions, and cyber warfare capabilities, has conferred upon them the strategic upper hand in their conflict with the non-state actor Hamas. The technological edge has allowed Israel to mitigate the impact of rocket fire from Gaza and prevent large-scale civilian casualties within its borders (Shapir, 2021). This technological superiority is not only a force multiplier in military operations but also an important factor in maintaining Israel's deterrence strategy. Impact on Civilian Casualties: Success achieved by Iron Dome in the interception of incoming rockets has been cardinal in limiting civilian casualties in Israel, clearly exemplifying how technology can go a long way in protecting populations in regions of conflict (Herzog, 2017). This was crucial in the 2023 Gaza War, where Hamas launched hundreds of rockets into Israel. The precision of Israel's military strikes also minimized collateral damage in Gaza, though critics have claimed that the overall impact on Palestinian civilians was disproportionate.

Strategic Deterrence: Israel's advanced air force, capable of executing high-precision strikes, has been a core part of its strategy to disarm Hamas' infrastructure and leadership while signaling to other regional adversaries that Israel's defense capabilities are unmatched. This technological edge serves as a visible deterrent to potential aggressors in the region (Shapir, 2021).

Deterrence as Central Military Doctrine

Among the guiding principles upon which Israel bases its military doctrine is deterrence. Indeed, the study showed that Israeli military statecraft is primarily driven to ward off any future attack and to maintain national security through a combination of pre-emptive actions and punitive strikes. Commonly called "punishment deterrence," this consists of deterring enemies by an exhibition and demonstration of one's capability and will to act resolutely against any threat (Herzog, 2017; Shapir, 2021).

Preemptive Strikes and Strategic Messaging: Israel's decision to carry out preemptive airstrikes on Hamas targets during the Gaza War reflects this deterrence-driven strategy. These strikes are intended to cripple Hamas' operational capabilities and reinforce the message that Israel will not hesitate to act when provoked. This tactic is also an attempt to maintain a balance of power in the region, ensuring that other militant groups understand the consequences of taking hostile actions against Israel (Kfir, 2020).

Psychological Warfare: A critical aspect of Israel's deterrence strategy is psychological warfare, in which military actions are not only a response to immediate threats but also an attempt to shape the adversary's behavior in the future. By showcasing its military might and technological capabilities, Israel aims to deter Hamas and other groups from escalating the conflict further (Herzog, 2017). This would fall in line with coercion theories in international relations, wherein the sole goal is to raise the costs of aggression prohibitively.

Intelligence and Cyber Operations as Force Multipliers

Intelligence gathering and cyber operations have indeed proved to be significant ingredients of Israeli military statecraft. Put together, these capabilities grant Israel the leeway for very precise missions, mostly with few civilian casualties. Intelligence from Mossad, Shin Bet, and other intelligence agencies has allowed Israel to strike high-value Hamas targets, such as military leaders and weapons storage facilities, while reducing the likelihood of escalation (Kfir, 2020).

Intelligence-Led Strikes: In the Gaza War, Israel relied on current intelligence to track practically every move of Hamas and launched surgical strikes against their functionaries. According to Shapir, 2021, drone surveillance and satellite imagery hint at ways of locating and neutralizing threats long before they reach an imminent threshold. **Cyber Warfare:** Israel has also leveraged cyber operations to disrupt Hamas' communications and missile-launching capabilities. These cyber operations, which are often conducted covertly, have proven to be effective in diminishing Hamas' operational capacity without direct confrontation (Kfir, 2020). This emphasizes Israel's dual approach to warfare—combining kinetic military force with non-kinetic means such as cyber- attacks and information warfare.

Public Diplomacy and Media as Tools of Strategic Communication

The study highlights that Israel has developed a sophisticated approach to public diplomacy during its military operations. Media strategies are used to justify military actions and shape international and domestic opinion about the necessity of Israel's defense measures. This helps Israel maintain political support both at home and abroad, while mitigating international criticism (Nye, 2004).

Framing Military Actions: Israel's use of public relations during the Gaza War emphasized that its military operations were a necessary response to the aggression posed by Hamas. Israeli officials regularly framed their actions as defensive, aimed at protecting civilians from terrorist attacks. This narrative has been particularly important in garnering international support or at least neutralizing international condemnation (Luttwak, 2001).

Soft Power and Media Influence: In line with Joseph Nye's theory of soft power, Israel's media strategy seeks to influence public opinion not through coercion but by shaping the narrative. The use of digital platforms and real-time media coverage, including videos and infographics that show the effectiveness of Israel's missile defense systems, plays a significant role in creating a favorable perception of Israel's actions during times of conflict (Nye, 2004).

Discussions

The research brings up several timely issues that bear far-reaching implications for the Israeli military strategy and its mission in the Middle East, as well as an ethical evaluation of its actions. It underlines some critical ethical concerns: the obviously higher toll that military operations have on civilians, moral motives in asymmetric warfare, and finally, larger outcomes that military action has in an urban setting. The technological edge, epitomized by systems such as the Iron Dome and cyber warfare capabilities, provides Israel with an unparalleled ability to defend its citizens while projecting power in ways that shape the broader regional security landscape (Shapir, 2021; Herzog, 2017).

Consequently, deterrence, particularly its pre-emptive and punitive forms, lies at the heart of Israel's military doctrine, reviving the understanding that military force is employed not only in neutralizing an impending threat but also in preventing further escalation in the process. Herzog (2017) postulates that deterrence spotlight, however, needs to be judged in perspective with Israel's overall strategic objectives-security sustenance, and state survival in a grossly unstable region. As demonstrated during the Gaza War, Israel's ability to launch precise airstrikes, supported by intelligence operations, has proven to be an effective means of incapacitating Hamas' military infrastructure while maintaining the appearance of restraint (Kfir, 2020; Shapir, 2021).

As Israel forges ahead amidst these challenges of multiplicities, lessons from the 2023 Gaza War will inform future military and diplomatic moves, thus solidifying a prudent approach balancing security and the humanitarian costs of modern warfare. Recommendations toward strategic improvements for the State of Israel's military strategy in light of findings and analysis conducted for the paper on Israel's military statecraft regarding the 2023 Gaza War are founded on security concerns, ethical challenges of modern warfare, deterrence, technological innovation, intelligence operations, ethics in warfare, and international diplomacy. Contemplation on these salient areas will go further to consolidate Israel's position, hedge the human cost of the conflict, and long-term stability in the region.

1. Enhance Cyber Defense and Attack Capability Israel's military statecraft, particularly in the context of the Gaza conflict, heavily relies on advanced cyber warfare to disrupt enemy operations. The effectiveness of cyber operations in neutralizing Hamas' communications and missile-launch systems has been a major factor in Israel's ability to control the escalation of the conflict (Kfir, 2020). As war is fast becoming part of the digital world, Israel should continue to develop its cyber defense mechanism so as to defeat any counterattack from enemies and protect the vital national infrastructure.

Recommendations

Israel should invest further in both offensive and defensive cyber capabilities, ensuring its systems can effectively disrupt the cyber operations of adversaries while minimizing the risks of retaliation through cyber-attacks. This includes strengthening Israel's cyber intelligence apparatus, ensuring it has the ability to detect and neutralize threats before they materialize. As cyber warfare becomes more sophisticated; Israel must remain at the cutting edge of technological warfare to ensure its security and safeguard critical assets. Increasing resources for cyber defense infrastructure and countermeasures will allow Israel to maintain its technological advantage (Kfir, 2020).

Move toward more proportionate approaches in urban warfare

One of the key ethical challenges that Israel faces in its military statecraft, especially in conflicts like the Gaza War, is the disproportionate impact on civilian populations. While Israel's technological superiority, such as the Iron Dome missile defense system and precision-guided munitions, significantly reduces the risk to Israeli civilians (Herzog, 2017), the densely populated nature of Gaza means that Palestinian civilians often bear the brunt of the military response. Israel should explore more innovative tactics and technologies to further minimize civilian harm during urban operations. This could include enhancing non-lethal weaponry, warning systems that allow civilians to evacuate ahead of airstrikes, and developing targeting systems that prioritize military objectives even further. Adopting a more proportional approach to warfare can help mitigate civilian casualties and damage to civilian infrastructure. Such strategies would not only improve Israel's moral standing on the international stage

but could also diminish the leverage of its adversaries, who often use civilian casualties to galvanize anti-Israel sentiment (Herzog, 2017). Furthermore, a focus on humanitarian considerations aligns with international norms and could reduce Israel's vulnerability to global criticism and potential legal challenges.

Increase Intelligence Cooperation with Regional Allies

Israel's military doctrine is highly reliant on its intelligence operations, which have proven essential in preempting threats and conducting precise military strikes. The role of intelligence agencies like Mossad and Shin Bet in targeting key figures and dismantling Hamas' infrastructure is central to Israel's success (Kfir, 2020). However, Israel's reliance on its own intelligence networks, while effective, should be complemented by broader regional intelligence cooperation.

Israel should prioritize the enhancement of intelligence-sharing agreements with regional allies, particularly those that face similar threats from radical groups, such as Egypt and Saudi Arabia. Strengthening these partnerships can improve Israel's ability to detect and preempt threats in real time. Intelligence cooperation can lead to more efficient and effective counterterrorism efforts, especially when it comes to identifying cross-border smuggling operations and tracking militant movements (Shapir, 2021). Greater regional collaboration could also reduce the chances of intelligence gaps, allowing Israel to take swift and targeted actions in neutralizing threats.

Expand the Role of International Legitimization through Diplomatic and Media Strategies

Military actions by Israel, particularly within the Gaza Strip, are always within the full glare of international publicity. Public diplomacy and media strategy by Israel influence both domestic and international opinion on its military actions. Israel's public diplomacy should be directed at proactive engagement in giving meaning to the ethical underpinnings of its military decisions through openness with the international community. It is suggested that Israel will further develop public diplomacy, describing military actions in the frame of self-defense, while at the same time being more open about challenges it needs to minimize civilian casualties. It presupposes resorting to social media and international news outlets while publishing real-time information on military actions, consideration of human rights, and measures taken to minimize casualties among non-combatants. By proactively engaging in diplomatic channels and media strategies, Israel can help control narratives that may otherwise be dominated by adversary propaganda. This can prevent the escalation of international criticism and garner greater understanding of Israel's security needs in a conflict-driven region (Nye, 2004). Expanding Israel's media outreach will also allow it to appeal to neutral parties and reinforce its image as a nation committed to international law and humanitarian values.

Strengthened Regional Peacemaking and Long-term Conflict Resolution

Israeli military statecraft efficiently manages short-term security concerns; it does not really deal with the root political issues of long-term conflict, particularly the Israeli-Palestinian one. In this sense, even while it suppresses immediate threats, this military approach does not cure the deep political grievances which breed this continuous cycle of violence. Israel should consider long-term projects of peacebuilding with the leadership of Palestinians and regional actors, comprising economic development of Gaza, the opening of new diplomatic conduits to the Palestinian authorities, and encouraging international support for an overall peace treaty that could take into consideration security concerns, territory, and humanitarian needs. While Israel's security measures are crucial in the short term, a lasting peace will require more than just military superiority. Promoting economic growth and infrastructure development in Gaza, coupled with political dialogue, can pave the way for a more sustainable and peaceful future. This would also reduce the reliance on military interventions and build regional stability, ultimately preventing the recurrence of violence (Herzog, 2017).

Resorting to preventive military action

Pre-emptive strikes, designed to neutralize threats long before they materialize, have formed the epicenter of Israeli military doctrine. Yet, deeper ethical and strategic effects pertain to impacts on civilians and the potential for escalation.
