*This paper assesses **The Anglo-Portuguese Alliance** birthed through the Treaty of 1373, but formalized via the Windsor Treaty in 1386. This study adopts a qualitative, descriptive approach, relying on secondary data obtained through desk research. The theoretical framework considered most effective for this analysis is **realism**, particularly its emphasis on strategic interests and power dynamics - Realism highlights how nations prioritize their own security and survival in an anarchic international system and the alliance between Britain and Portugal is a prime example of this dynamic in the international system. Findings show the significant factors that made the alliance the oldest running in the world, its key successes and challenges vis-à-vis the crucial need for reform to enable it meet the demands of the 21st century. The study recommends the restructuring of the fundamental aspects of the alliance, to encompass modern realities.*

Introduction

There are several alliance treaties between England and Portugal, the most significant being the Treaty of London in 1373, which marked the foundation of the Anglo-Portuguese alliance. In total, between 1353 and 1943, thirty-two treaties and conventions were signed by the two countries for commercial and military purposes, according to Lynne Booker (2020) of the Algarve History Association. The Anglo-Portuguese Alliance, also known as the Oldest Alliance, is a long-lasting pact of friendship and mutual support between the United Kingdom (UK) and Portugal, dating back to 1373. It's considered the world's oldest military alliance, with backgrounds tracing back to 1294 and made official with the signing of Treaty of Windsor in 1386. Historical origin of the coalition began with a commercial agreement in 1353 and was converted into a military and political alliance in 1373. As regards its formalization, the Treaty of Windsor in 1386 solidified the alliance with a pact of perpetual friendship. The Anglo-Portuguese Treaty is symbolic of an 'Enduring Legacy' in view of the fact that the alliance has undergone numerous historic eras, including periods when Portugal came under the control of Spain as well as the Napoleonic Wars era.

Apart from military cooperation, the alliance is inclusive of political support. The alliance has involved mutual support in times of conflict, including the Napoleonic Wars where Britain sent troops to Portugal. Realism highlights how nations prioritize their own security and survival in an anarchic international system and the alliance between Britain and Portugal is a prime example of this dynamic.

An elaboration of this theoretical framework shows the following:

1. Strategic Interests: The alliance was forged and sustained because both nations recognized the mutual benefits of cooperating against common threats. For example, in the face of French and Spanish power, Britain and Portugal formed a counter-balance (Trowbridge, 2016; The GOV.UK blogs, 2016)
2. Power Dynamics: Realism also underscores how the stronger party (Britain) often exerted significant influence over the weaker partner (Portugal), potentially exploiting the alliance for its own gain. This dynamic is evident in the historical record, where British authorities sometimes invoked the alliance selectively or manipulated its terms to their advantage.
3. Security Concerns: The alliance provides a clear example of states seeking security through alliances in a system where they lack a world government to enforce peace.(The Council on Geostrategy (n.d); Elefteriu, 2023).
4. National Interests: Both nations pursued their own national interests within the framework of the alliance, whether those interests were related to trade, security, or dynamic concerns. For example, the Treaty of Windsor (1386) solidified the alliance through dynastic marriage and mutual defense obligations. (Livermore (2025).

Realism's suitability as a framework for the analysis of Anglo-Portuguese Alliance is hinged on the fact that it emphasizes the importance of power, security, and self-interest in international relations (Elashkar, 2020; Leite, 1998).

Findings and Discussion

Salient Provisions of the Anglo-Portuguese Treaty: The alliance which came to the fore following the signing of the Treaty of Windsor of 1373, established a “perpetual friendship, union, and alliance” between England and Portugal. It guaranteed mutual aid and commitment to never warring against each other, and it served as a foundation for the ongoing Anglo-Portuguese alliance. The treaty also included provisions for reciprocal assistance and trade, ensuring that both nations could trade on favourable terms.

Key provisions of the Treaty include:

1. Perpetual Friendship and Alliance: The treaty established a “perpetual friendship, union, and alliance” between the two nations, committing them to never warring against each other.
2. Mutual Aid and Assistance: Both nations agreed to provide each other with aid and support in times of need, including military aid, if requested.
3. Trade and Commerce: The treaty ensured that both English and Portuguese merchants could trade in each other’s domains under the same favourable terms as the subjects of that country, fostering economic ties.
4. No Friendship with Enemies: The treaty stipulated that neither nation would form friendships or alliances with the enemies of the other.

5. Reciprocal Assistance: If either nation was attacked or threatened, the other was obligated to provide assistance and defense.

Highlights of Landmark Implementation: The Anglo-Portuguese Treaty of 1373, signed in London, laid the foundation for a lasting alliance between England and Portugal, with examples of its implementation including military support and trade agreements. The treaty, which formalized a verbal agreement made in 1294, provided for mutual defense and aid, as well as trade and transit rights. Here are some examples:

1. Military Support: The alliance was invoked during the Battle of Aljubarrota in 1385, where English reinforcements helped John I of Portugal secure the throne.
2. Trade and Transit: The treaty guaranteed freedom of trade and transit for citizens of each nation in the other's territory, as if they were natives.
3. Defense and Security: The treaty's provisions for mutual aid were invoked during the eighteenth and nineteenth centuries, including the successful defense of Portugal against a Spanish invasion in 1762 and the thwarting of Napoleon's attempts to conquer Portugal during the Peninsular War.
4. Political and Diplomatic Support: The treaty provided a basis for the marriage of John I of Portugal to Philippa of Lancaster, further strengthening the alliance.
5. World War II: During WWII, Portugal, despite its neutrality, granted the British Royal Navy facilities for refueling in Portuguese ports, citing the alliance.
6. Falklands War: In 1982, the treaty was invoked again, requesting the use of air and naval facilities in the Azores during the Falklands conflict.
7. Contemporary Relevance: The alliance remains valid and is recognized by both the United Kingdom and Portugal.

Challenges in the Implementation of the Anglo-Portuguese Alliance: The implementation of the Anglo-Portuguese Treaty of 1373, while initially intended as a strong foundation for alliance, faced significant challenges, including political shifts, dynastic conflicts, and the temporary suspension of the treaty during the Iberian Union. While the treaty laid the groundwork for a long-lasting alliance, its effectiveness was sometimes hampered by changing political landscapes and rivalries.

However, the initial military objectives of the alliance ultimately failed, and the treaty's effectiveness in achieving its primary goals was questioned.
2. Dynastic Conflicts and Political Shifts: The alliance was further tested by dynastic conflicts and political shifts. For example, the marriage of Philippa, daughter of the Duke of Lancaster, to John I of Portugal in 1387 added a dynastic element to the alliance, helping to maintain it during periods of uncertainty. However, the Iberian Union (1580-1640) saw Portugal under Spanish rule, effectively suspending the treaty and leading to a period of political and military distance between the two nations.
3. The Iberian Union: The period of Spanish rule over Portugal from 1580 to 1640 (Iberian Union) presented a major challenge to the alliance. During this time, the Anglo-Portuguese treaty was effectively suspended, and Portugal's relationship with England was strained.

4. Temporary Suspend of Treaty: During the Iberian Union, the initial Anglo-Portuguese treaty of 1373 was temporarily suspended, while the Treaty of Windsor (1386) was also affected.
5. Ongoing Challenges: Even after the restoration of Portuguese independence in 1640, the alliance continued to face challenges, including economic crises, and conflicts with other European powers.

Despite these challenges, the Anglo-Portuguese alliance has endured for over 650 years, surviving major historical events and political transformations. The alliance has been invoked numerous times throughout history, including during World War II, where Portugal played a crucial role in supporting the Allied cause, despite its own neutrality (Araujo (2020)).

Conclusion

The Anglo-Portuguese Treaty of 1373, signed at Windsor, cemented a lasting alliance between England and Portugal, promising mutual aid, trade, and military support, and is considered the world's oldest active political alliance. It arose from Hundred Years' War and John of Gaunt's claim to the Castilian throne. The treat's clauses, including those on mutual security and commercial ties, were crucial in solidifying the alliance.

In term of context, the treaty emerged from the Hundred Years' War, where England and France were locked in conflict and involved various powers supporting either side, John of Gaunt, a claimant to the Castilian throne, sought support from Portugal.

Key provisions indicate that the treaty established "perpetual friendships, unions, and alliances". It included promises of mutual aid, trade opportunities, and military support

On impact, the treaty not only solidified the alliance but also influenced the course of the Hundred Years' War and expanded the conflict to the Iberian Peninsula.

The Anglo-Portuguese Alliance has a long-lasting legacy, having endured for over 650 years, remaining in force and evolving to meet contemporary challenges like terrorism, cyber-security, and climate change.

In the area of modern relevance, the alliance continues to be a cornerstone of international relations, with both nations cooperating on various issues, including defense, trade, and global concerns.

Recommendations

The 1373 Anglo-Portuguese Treaty, signed in London, established a "perpetual alliance" between England and Portugal, with provisions for mutual and strengthened commercial ties. It served as a foundational agreement, later reinforced by the Treaty of Windsor in 1386, and has remained in effect as the world's longest-standing continuous peace treaty.

Here's a breakdown of potential recommendations for the 1373 treaty, considering its historical context:

Mutual Security being the core of the treaty's strength lies in its commitment to mutual defense. This could be further reinforced by: modernizing the concept of "mutual aid", since the original treaty focused on military support, contemporary interpretations could extend this to include economic assistance, diplomatic cooperation, and even cyber-security support; establishing clear protocols for activation by defining specific circumstances under which mutual aid would be invoked would enhance the treat's practicality and avoid ambiguity.

Commercial Ties in the treaty included provisions for fair trade between the two nations. This can be strengthened by promoting free trade by way of reducing tariffs and barriers to trade in order to solidify economic ties and foster mutual prosperity; encouraging investment by providing incentives for investment in each other's economies which would stimulate growth and create jobs; expanding cultural exchange by facilitating the movement of people and ideas on order to foster deeper understanding and strengthen the bond between the two nations.

Longevity and Adaptability which is the pivot of the treaty's enduring strength lies in its ability to adapt to changing circumstances which requires: regular reviews and updates, by periodically reviewing the treaty's terms to ensure they remain relevant to the evolving global landscape; flexibility in interpretation by allowing for a degree of elasticity in applying the treaty's principles to address new challenges and opportunities.

There's need for more public awareness. The treaty's historical significance and enduring value should be promoted through educational initiatives by integrating information about the treaty into school curricula and public education programs; cultural events and celebrations by organizing events that commemorate the treaty's anniversary and highlight the long-standing relationship between the two countries.

Practical considerations may include modernizing the original language of the treaty to reflect contemporary geopolitical realities and legal frameworks; integration with other treaties by viewing the treaty in conjunction with other existing agreements between the UK and Portugal, creating a comprehensive framework for cooperation; consultation and collaboration in the sense that any revisions or updates to the treaty should be undertaken in close consultation with both governments and relevant stakeholders.

By carefully considering these recommendations, the Anglo-Portuguese Treaty of 1373 can continue to serve as a powerful symbol of enduring friendship and cooperation between the two nations.
